2. **Academic performance** as reflected in high school transcripts.

**Your scholarship application is due to the MASH counseling center Friday April 8, 4 PM.**

A committee consisting of Wildcat Foundation board members, and the senior. Applicant packets are anonymous for the selection process. The Wildcat Foundation will announce the scholarship recipient at the Senior Awards Ceremony, typically scheduled during the week prior to Commencement.
